**This event will be held rain or shine.** Please plan accordingly if needing pop up, weights etc. this is an outdoor event. Application and Fee must be received by no later than Monday March 4, 2019 (All Fees are nonrefundable after February 15th) Vendors keep **100%** of their proceeds for the sales on the day of the event.

No vendor will be permitted to erect signs or display products obstructing the view of other vendors, also it is prohibited to distribute promotional materials outside the limits of your booth.

Confirmation is based on the dates and times of application submissions AND Payment. We reserve the right to turn down applications (and return fees) based on number of applications received and overall variety of applications.

Vendors are responsible for all Set up and Cleanup of their booth space, and their immediate surrounding area.

**Food Truck/ Food Vendor application Acceptance Policy:** All food trucks and vendors must be able to operate independently of any resources at Central Park Including water, electrical, refrigeration and any materials.

Food Vendors must provide: proof of insurance, food safety certificates, Fire extinguishers, and environmental pads to absorb any liquids, oils for containment and are prohibited from selling Alcohol products outside of the beer garden.

**All Vendors Load In/ Load Out:** Set up begins at 8am on Saturday's 3/16 event. Event staff will assist in direction to assigned space, please bring necessary help, cart, and dollies. There are no vehicles permitted on grass park area without prior authorization. Please be courteous to City Staff/ Volunteers. Load out will start no earlier than designated end time of event. No vehicles will be permitted in Central park area prior to 5pm.

\*Parking will be across the train tracks behind City Hall for all Vendors. \*
