## RULES FOR USE OF THE FILLMORE HIGH SCHOOL TRACK FACILITY

The following are rules that have been established in order to maintain a safe and enjoyable environment. Rules are to be followed at all times by the participant using Fillmore High School track facility. Failure to abide by these rules will result in loss of privileges and the participant will be asked to leave the track facility immediately.

1. Run, walk or jog in the outside lanes.
2. Users must wear athletic garments & appropriate shoes.
3. No golfing, shot putting, javelin, use of long spike shoes. (no more than ¼ inch, prefer 3/16 inch).
4. No food, drinks or gum allowed on the track or field (Water ONLY)
5. No open flames, fireworks, welding etc.
6. No animals allowed at any time.
7. No rollerblades, roller skates, skateboards, bicycles, or strollers permitted. (Wheelchairs ok)
8. Do not practice "track starts" on the turf.
9. Do not use high jump, long jump or pole vault pits.
10. Do not enter the main campus at Fillmore High School.
11. No public restrooms, telephones or lights are available at the track.
12. The City of Fillmore and the Fillmore Unified School District are not responsible for lost or stolen belongings.
13. Everyone entering the track facility must have paid a \$25.00 use fee, signed the necessary paperwork and received their own individual scan card. No other individuals are to enter the track using your scan card or accompanying you into the track facility with you, without having purchased the annual use fee previously mentioned. If you lose or damage your card please inform the Parks and Recreation Department by calling 805-524-1500 ext. 713

**The following are probated when using the track facility:**

Possession of weapons, use of alcohol, narcotics, smoking, persons under the influence of alcohol or narcotics, pets and glass bottles. By signing below, I acknowledge receipt and understanding of these rules and agree to follow them. I understand that any infraction of these rules will result in loss of the privilege to use the track facility.

**Waiver and Release:** In consideration of being permitted to participate in the use of the Fillmore High School "Track" as part of the City Recreation Department's Walking/Running Fitness Program "Activity", I, for myself, my heirs, personal representatives of assigns, do hereby release, waive, discharge, and covenant not to sue the City of Fillmore, nor Fillmore Unified School District its officers, board members, employees, and agents from liability from any and all claims, including, without limitation, the negligence or gross negligence of the City of Fillmore, nor Fillmore Unified School District its officers, board members, employees and agents, resulting in personal injury, accidents or illnesses (including death), and property loss arising from, related to, but not limited to, participation in the Activity. **Assumption of Risks:** Participation in the Activity carries and use of the Track carry with them certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. For example, participants will be engaged in a strenuous sport of walking, running, or jogging, that involves physical exertion. Although the specific risks vary from one activity to another, the risks range from (1) minor injuries such as scratches, bruises, dehydration, and sprains; (2) major injuries such as joint or back injuries, broken bones, heart attacks, and concussions; and (3) catastrophic injuries including paralysis and death.

**I have read the previous paragraphs and I know, understand, and appreciate these and other risks that are inherent in playing softball and participating in the Activity. I hereby assert and affirm that my participation is voluntary and that I knowingly assume all such risks.**

**Indemnification and Hold Harmless:** I also agree to INDEMNIFY AND HOLD the City of Fillmore and Fillmore Unified School District HARMLESS from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities, including attorney's fees, brought or incurred as a result, direct or indirect, of my involvement in the Activity, and to reimburse the City of Fillmore or Fillmore Unified School District for any such expenses incurred.

**Severability:** The undersigned further expressly agrees that the foregoing waiver, release and assumption of risks agreement is intended to be as broad and inclusive as is permitted by the law of the State of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect to the maximum extent permitted by law.

**Acknowledgment of Understanding:** I have read this waiver of liability, assumption of risks, and indemnity agreement, fully understand its terms, and understand that I am giving up substantial rights, including my right to sue. I acknowledge that I am signing this agreement freely and voluntarily, and intend by my signature to completely and unconditionally release the City of Fillmore and Fillmore Unified School District from all liability to the greatest extent allowed by law.

I understand that this activity exposes me to the risks of personal injury, death, disability, property damage and/or loss (collectively, "Injuries"). With an understanding of these risks, I hereby acknowledge and agree, for myself, my heirs, personal representatives, administrators, executors, and assigns, as follows:

I agree that my participation and use of the Track and related premises is completely voluntary and for my recreational enjoyment. I assume any and all risks associated with my use of the Track including, but not limited to, the risk of physical injury. I am aware and understand these risks, hazards, and dangers present in my participation and use of the Track may lead to incurring Injuries. All such risks are known and appreciated by me. In consideration for being permitted to use the Track, I hereby waive and relinquish, fully release, forever discharge, and agree not to sue the City of Fillmore and the Fillmore Unified School District, including their elected and appointed officials, board members, officers, employees, agents, contractors, and volunteers (collectively, "Fillmore"), from any and all claims for personal injury including death or property damage, lawsuits, costs and expenses including attorney fees, arising out of, or in connection with, my use of the Track, any event or class taking place on the Track premises, or from whatever cause, including active or passive negligence of Fillmore or any other people using the Track. I understand that this Release may be a complete bar and defense to any action or other proceedings instituted or filed by me against Fillmore on account of any matter contained herein. This document is not intended to release any party from any act or omission of gross negligence.

I also understand that I am responsible for any injury or damage that I cause to others and/or to the Track and I agree to hold harmless, indemnify, and defend Fillmore from and against any and all third party claims or liabilities that may arise out of or in connection with my use of the Track.

I further agree that no oral representations, statements, or inducements apart from this Release have been made by Fillmore or anyone else with regard to the subject matter of this Release. This Release is intended to be construed broadly to the full extent permitted under the laws of the State of California, and if any portion thereof is held by a court of competent jurisdiction to be invalid, the balance shall, notwithstanding, continue in full legal force and effect.

I hereby represent that I am physically able to use the Track and that I have no medical condition that would cause participation in activities at the Track to be potentially hazardous to my health. I do hereby give permission and this Release constitutes an authorization for any certified emergency professional or health care professional to administer any type of medical treatment they deem necessary in case of an emergency.

**I DECLARE UNDER THE PENALTY OF PERJURY OF THE LAWS OF THE STATE OF CALIFORNIA THAT I: HAVE READ THIS RELEASE CAREFULLY, I FULLY UNDERSTAND IT, AND I VOLUNTARILY AGREE TO ITS TERMS; UNDERSTAND THAT ACCIDENTS MAY OCCUR DURING MY USE OF THE TRACK; AND AM EIGHTEEN (18) YEARS OF AGE OR OLDER AND AM FULLY COMPETENT TO SIGN THIS RELEASE:**

## RULES FOR USE OF THE FILLMORE HIGH SCHOOL TRACK FACILITY

The following rules have been established in order to ensure an enjoyable, safe, and well maintained facility. Rules are to be followed at all times by participants using the Fillmore High School track facility. Failure to abide by these rules may result in loss of privileges and the participant will be asked to leave the track facility.

The following ***are prohibited***:

1. Possession of weapons, use of alcohol or narcotics, smoking, persons under the influence of alcohol or narcotics
2. Food or drinks – this includes candy, seeds, gum, coffee, Gatorade, etc. (exception is WATER only – no glass bottles)
3. Sharp objects such as chairs, benches, high heeled shoes, or anything else that may penetrate or damage the turf or rubber track
4. Portable heaters, open flames, fireworks, etc.
5. Dogs or other animals
6. Golfing, shot putting, skateboarding, biking, in-line skating, scooters, strollers, etc.
7. Suntan lotions, oils, creams of any kind (please apply sunblock prior to entering the track facility)
8. Shade structures, or “pop-ups”, throughout entire stadium facility
9. Use of the high jump, long jump, or pole vault pits
10. Sharing scan card or bringing in additional participants

The following ***are required***:

1. Participants must wear running or walking shoes
2. Always lift/carry all items (do not drag)
3. Deposit all trash in trash receptacles that are provided
4. Everyone participating in the program must, on an annual basis:
  - Sign a City of Fillmore Parks & Recreation Department Registration Form and pay a **\$25.00** use fee
  - Sign a City of Fillmore Waiver of Liability, Assumption of Risks, and Indemnity Agreement
  - Sign a Fillmore Unified School District Voluntary Activity Informed Consent and Liability Release Acknowledgement and Assumption of Potential Risk Form
  - Sign this Rules for Use of the Fillmore High School Track Facility Form
  - Receive a scan card
    - Please be careful with scan card – do not bend, get wet, or place next to magnetic items
    - Replacement scan cards will cost \$15.00 per card
