This is the final addendum that will be issued for Spec. No.20-02. The following additions, corrections, and/or response to questions shall become a part of the Contract Documents and Specifications for the above-named project:

- 1) Addendum No 1, first sentence:
Replace: **“This is the final addendum that will be issued for Spec. No.20-02.”**
With: **“This addendum will be issued for Spec. No.20-02.”**

- 2) **Bidder’s Question:** What is the current monthly billing amount for this contract?
City Response: Refer to Addendum No.1, Schedules A and Schedule B for total monthly billing amounts.

- 3) **Bidder’s Question:** Are there any changes in the current rfp from the last?
City Response: Please bid on current RFP as presented by the City.

- 4) **Bidder’s Question:** What is the current crew size for this contract?
City Response: The City does not have this information to provide. Please bid the with your anticipated required crew size to meet the proposal requirements.

- 5) **Bidder’s Question:** What level is the Landscape Maintenance currently, and is the city satisfied?
City Response: The current level of required landscape maintenance is as specified in the RFP and that will satisfy the City.

- 6) **Bidder’s Question:** What irrigation systems are currently in place on all sites.
City Response: The City does not have an inventory of this information. The bidder is strongly encouraged to visit all sites prior to bidding.

- 7) **Bidder’s Question:** Schedule B, #34. Is there any special instructions in regards to maintenance of the bio filter.
City Response: There are no special instructions regarding maintenance of the bio filter.

8) **Bidder's Question:** Schedule B, #44. What is the responsibilities of maintenance within the pool area fence? Is the Tennis courts, and parkway in front of aquatic center included as well? I was not able to enter pool area on my site visit.

City Response: The Fillmore Aquatic Center (Item No.44) will include all landscaping maintenance as shown by the green boundary line in Appendix 1 (see page 30 of Appendix), which will include the tennis courts and the parkway in front of the aquatic center.

9) **Bidder's Question:** Schedule B, #48. What are the specs for maintenance of the stairs. Hardscape only and empty trash can? Do we include the landscape maintenance adjacent to the stairs all the way up?

City Response: 3rd Street Stairs (Item No.48) will include hardscape, empty trash receptacles and maintenance of adjacent landscape along the stairs.

10) **Bidder's Question:** Schedule B, #41. There were 5 Sespe street Medians on my ssite visit. Is this corrcet the RFP says 4?

City Response: You are referring to Schedule B, Item 40, Sespe Avenue Medians. The RFP is correct as shown. Schedule B, item No.54 will include the two additional medians on Sespe Avenue, near Central Avenue.

When submitting a bid for the project, this Addendum shall be acknowledged in the proposal and a signed copy of the Addendum shall be included in the bid package.
